Earlier this year, we announced plans and broke ground on a new corporate office.

The decision to move our headquarters from Spring Street in Fort Wayne was not an easy one. However, our new building at the corner of Lima and Wallen Roads in Fort Wayne will give us enough space to grow, to add services and to expand our staff so that we can continue to support you in achieving your financial goals.

The 27,000 square-foot building will include a full-service branch location attached to the corporate headquarters and will feature an exterior ATM and two drive-up lanes.

As construction continues, we expect to move into the new headquarters late summer of 2022.

All signatures must be valid Fort Financial members and must be at least 18 years of age.

Petitions must be returned to the Nominating Committee no later than **5:00 p.m. on Friday, January 28, 2022.**

If more than three nominees are validated, a special ballot will be mailed mid- to late- February. The results of the election will be announced at the Fort Financial annual meeting on **Tuesday, March 15, 2022.**
